## VISITORS' ACKNOWLEDGEMENT OF RISK MOAB JETT (REQUIRED READING)

You/your minor child (of applicable), may be hurt while participating. If you are unwilling to assume all the risks of you/your minor, DO NOT sign this document, in which case you/your minor will NOT be authorized to participate, and you will be refunded any monies you paid. If you sign this document BUT make any alterations to it, you are NOT authorized to participate.

1. Assumptions of Risks. Although Moab Jett has taken reasonable steps to provide you with appropriate equipment and skilled guides so you can enjoy an activity for which you may not be skilled, we wish to remind you this activity is not without risk. Certain risks cannot be eliminated without destroying the unique character of this activity. The same elements that contribute to the unique character of the activity can be causes of loss or damage to your equipment, or accidental injury, illness, or in extreme cases, permanent trauma or death. We do not want to frighten you or reduce your enthusiasm for this activity, but we do think it is important for you to know in advance what to expect and to be informed of the inherent risks.

I am aware that the type of wilderness expeditions operated by Moab Jett entails risks of injury or death to me. I understand the description of these risks is not complete and that other unknown or unanticipated risks may result in injury or death. I agree to assume responsibility for the risks identified hereon and those risks not specifically identified. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of the risks.

Each of the trips we offer goes into remote areas. Access to medical help is not immediately available. Communication is limited. Other risks include, but are not limited to dehydration and over exertion, rough terrain, sunburn, heat exhaustion/stroke, destructive wind and wind delays, and generally inherent risks when going into the wilderness.

These Jet Boats are high-powered boats operating in shallow waters with shifting sand and channels. Risks include, but are not limited to, running a ground cause delays and injuries (whiplash, maiming) resulting from sudden halt and injuries getting on and off the boat and walking in the backcountry. There is possibility of prolonged delays due to sandbars.

I REPRESENT AND WARRANT THAT I HAVE READ THE UNDERSTOOD THIS DOCUMENT, AM OF SOUND MIND, HAVE LEGAL AUTHORITY, AND FREELY ACCEPT AND FULLY ASSUME THE RISK THAT I/MY MINOR CHILD CAN SUFFER PROPERTY DAMAGE, ILNESS, SEVER PERSONAL INJURY OR EVEN DEATH BY PARTICIPATING, not only the ways described above, but also in ways that are unknown and unexpected, even if I follow/ my minor child follows instructions or advise.

2. Responsibility/Liability. Moab Jett uses quality equipment and our guides are licensed and prepared to serve your needs. However, on a wilderness expedition, unexpected circumstances may arise. It is customary among outfitters to require you to sign an "Assumption of Risk" form prior to departure. This releases Moab Jett from responsibility for your personal injury and loss of or damage to your equipment and/or personal articles. We reserve the right to withdraw any tour or to make any change in the tour, with or without notice, that Moab Jett may deem necessary.

Moab Jett makes every reasonable attempt to operate your expedition as advertised, but sometimes weather conditions, river condition, emergencies, amount of registrants, strikes, war or other circumstances beyond our control cause us to make necessary alterations; such alteration will not be the cause for any refund or adjustment in expedition prices.

I agree to refrain/cause my minor to refrain from and not to be impaired by the use of alcohol or any controlled substance (except as medically authorized) while participating.

- 3. Waiver, Release and Indemnification. I certify that I am, and/or my minor(s) are fully capable of participation in this activity. Therefore, I assume full responsibility for myself, and/or, including my minor children, for bodily injury, death and loss of personal property and expenses thereof as a result of those inherent risks and dangers and of my negligence in participating in this activity.
- 4. <u>Photo/video Release:</u> I understand that as part of the trip, Moab Jett may take a picture or video that includes me. I agree that Moab Jett may do so, and may use the image for sales to myself or others, to promote trips in the future.
- 5. <u>Infectious Disease</u> Moab Jett has established strict measures and is following good standards of care specific to COVID 19 as per the CDC guidelines, Utah sate health department, and Grand county health department. I understand that participating in any tour with Moab Jett may be considered inherently dangerous and may cause serious or grievous injuries, including COVID 19 infection.

I have read, understood and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon me, my heirs, assigns, personal representative and estate and for all members of my family, including any minors accompanying me.

I understand and agree that Moab Jett is not an insurer of my/my minor child's conduct. TO THE FULLEST EXTENT PERMITTED BY LAW, I HEREBY RELEASE, WAIVE, COVENANT NOT TO SUE, AND DISCHARGE MOAB JETT AND ALL OF ITS TRUSTEES, DIRECTORS, MANAGERS, OFFICERS, EMPLOYEES, VOLUNTEERS, AGENTS AND REPRESENTATIVES (COLLECTIVELY, THE "RELEASEES") FROM ANY AND ALL LIABILITY, CLAIMS, DEMANDS, AND CAUSES OF ACTION WHATSOEVER ARISING OUT OF OR RELATED TO ANY LOSS, DAMAGE, OR INJURY, INCLUDING DEATH, THAT MAY BE SUSTAINED BY ME/MY MINOR CHILD OR LOSS OF DAMAGE TO ANY PROPERTY BELONGING TO ME/MY MINOR CHILD, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE, ARISING OUT OF OR RELATED TO MY/MY MINOR CHILD'S PARTICIPATION. I AGREE THAT THIS DOCUMENT SHALL BIND MY GAURDIAN, ASSIGNS, HEIRS, ADMINISTRATORS AND EXECUTORS FOREVER.
